#### WATTS.HAPPENING COOKIE POLICY

Elia Transmission Belgium SA/NV (hereinafter referred to as 'Elia', 'we', 'our') undertakes to protect and respect your privacy (hereinafter referred to as 'you', 'your').

To this end, Elia protects the personal data of its customers as well as its partners, suppliers and online users/visitors collected via cookies, tags or tracers (hereinafter generally referred to as 'cookies') and processes said data with the greatest possible care.

#### 1. Identity of the data controller

The controller of your personal data for Watts.happening is Elia Transmission Belgium, having its registered office at Boulevard de l'Empereur 20, 1000 Brussels, Belgium, a public limited company under Belgian law, registered in the Crossroads Bank for Enterprises under the number 0731.852.231. #### 2. About cookies

Cookies are small data files that are downloaded to your device (e.g. a tablet, smartphone, PC or laptop) when you visit Watts.happening. They may collect information about your use of Watts.happening or allow us to identify you and your device when you return to Watts.happening at a later date. Cookies also enable us to recognise your device.

3. What types of cookies do we use?

# 3.1. General information

We use both session and persistent cookies on our website.

We use **third-party** cookies. Third party cookies are set by websites that belong to a domain differing to that displayed in the address bar when you visit an Elia website.

We also make use of **third-party requests**, which are requests made to external servers to display content from other applications or websites (e.g. Hotjar survey). Even though these applications do not install any cookies, they may still collect information about visitors via settings.

#### 3.2. Cookies used on this website

We use the following types of cookies on our website:

**A. Strictly necessary cookies** are essential for allowing visitors to browse our website and use its functions. As they are a technical necessity, these cookies are installed once you access the website and cannot be rejected.

**B.** Analytical/performance cookies collect information about how you use our website (e.g. the web pages/functions you visit/use most often). They help us improve the operation of the website and can be rejected. This section categorises and describes the various cookies used on this website based on their purpose, type and supplier, where applicable.

#### 6. Retention period of collected data

The retention period of the data collected by various cookies may vary depending on whether

the cookie is installed by Elia or by third parties. We are not responsible for the retention period of third-party cookies.

Any personal data collected by Elia will not be retained for longer than is strictly necessary for the purposes set out in this Policy. Beyond that, said data will be deleted at the end of the retention period, unless a longer period is permitted or required pursuant to a legal or regulatory obligation, or if the data are subject to a process of anonymisation in order to make it impossible to 're-identify' individuals. As data that have undergone this process are no longer personal, they can be kept for an unspecified period of time and can be exploited, specifically to produce statistical reports.
